Another win in Maryland's federal district court restored scholarships for low-income students who attended a Christian elementary school.

Paul clerked for the Honorable Michael S. Kanne on the United States Court of Appeals for the Seventh Circuit and litigated as an associate attorney at Ice Miller LLP in Indianapolis. He also served as an officer in the United States Air Force for more than four years, working in military satellite communications.

Paul received his law degree *magna cum laude* from the University of Illinois College of Law in 2017. During law school, Paul externed with the Vatican's Pontifical Council for the Family in Rome. He received his Bachelor of the Arts from the University of Illinois at Urbana-Champaign in 2009, and was elected to serve the Urbana campus on the University's Board of Trustees. Paul is admitted to the state bars of Illinois and Indiana, the District of Columbia, the U.S. Courts of Appeals for the Second, Seventh, and Eleventh Circuits, and multiple federal district courts.
